1. **Promoter.** The silent auction is being sponsored by Seattle Progressive Preschool, Inc. ("SPP"), 3201 East Republican Street, Seattle, WA 98112, email: genevievegeiger@gmail.com (the "Promoter"), and administrated by our third-party administrator, 32Auctions, at www.32auctions.com (the "Administrator").
2. **Agreement to Terms.** Please read the silent auction terms and conditions ("Terms") carefully. These Terms apply to all persons bidding in the silent auction conducted by Promoter and Administrator. If you take part in this silent auction, you (the "Bidder") agree to be bound by these Terms and accept that the Promoter's decision is final and shall be made by the Promoter in the Promoter's sole and unfettered discretion. Your bidding implies acceptance of these Terms.
3. **Silent Auction Period.** The silent auction will start on 11/28/17 at 9:00 am PST and close on 11/30/17 at 9 pm PST. The Promoter will not be liable for any bidding entries received after the silent auction closing date. All online entries must be received by 11/30/17 8:59 pm PST.
4. **Eligibility Requirements.** It's open to all citizens and legal residents of the United States at the time of winning and receiving any Prize herein ("participant"). Each bidder at the time of entering the silent auction must be over the age of 18 (eighteen).
5. **Bidder Registration - How to Enter.** All Bidders must activate the Promoters associated link through our Administrator - <https://www.32auctions.com/SPPauction2017>. A copy of the silent auction Terms will be made available to the Bidders and can be viewed under the Promoter's Website Page. All Bidders should sign up for a username for semi-anonymous bidding. Bidders must use their Bidder user name on the bid sheet for their bid to be valid.
6. **Winner Selection Procedures.** Once a Bidder has a "won" an item, the Bidder will be contacted via email by the Administrator and/or the Promoter with instructions on how to redeem the Bidded Item. The Administrator and/or the Promoter will verify identification and that payment has been made in full. The contact email may include further information for tax purposes. 7. **Bidded Items:** All sales are final. There will be no exchanges or refunds unless otherwise noted. All items are "as is." 9. **Disclaimer of Responsibility for Entries.** Promoter shall not be responsible for any changes, substitution, withdrawal, cancellation or postponement of any part of the silent auction and/or the Bidded Items beyond its reasonable control.
